Meeting called to order by Mike Jackman, SSCPP Chair at 9:00a.m. Everyone was welcomed and gave self-introductions. All shared how housing affects their work.

Mike reviewed SSCPP's funding opportunities: Mini grants up to \$3,500, Health Compass grants up to \$7,500 and Health Literacy grants up to \$10,000. We are also finalizing RFP for our SSCPP behavioral health grant for up to \$25,000 per year for up to three years. Grant writer had health issues but is back to office and working on RFP.

- Program is for chronic pain management through an alternative treatment (yoga). It is a complement to medication for pain management.
- Those served were ages 40-80. Some have been experiencing pain for years.
- SSH is committed to improving access to care and helping patients reach their full potential. Focusing on quality of life-sleeping better, breathing exercises, savings money on prescriptions.
- An issue was transportation to class. Buying tools for the yoga class that were safe for the individuals to use helped a great deal.

Carl Nagy Koechlin

- Housing Solutions is a regional affordable housing delivery mechanism for Southeastern MA.
- Offer a rental assistance program, homelessness prevention program (RAFT), and HomeBASE for homeless families. Also run housing consumer information center and offer nearly 400 affordable housing units.

- Biggest challenge to address housing needs- resistance at the local level to things such multifamily housing. We are chasing a shrinking number of units.
- Offer workshops and trainings. Can present to case managers at agencies.
- Demonstrating the cost-effectiveness of potential solutions can help make an impact.

- Shared national Point in Time Homeless Count data from 2016. Half a million people were found to be homeless and 37% of these individuals had behavioral health issues.
- "An end to homelessness means every community will have a comprehensive response in place that ensures homelessness is prevented whenever possible, or if it can't be prevented, it is rare, brief and not a reoccurring experience"
- Discussed the Medication Assisted Treatment Continuum such as sober homes, outpatient services, etc. Need to understand how each one impacts the people we serve.
- Things to consider: shrinking supply of appropriate housing options, outreach and engagement, ongoing community-based support. Collective impact is key.
