Meeting called to order by Mike Jackman, SSCPP Chair at 9:00a.m. Everyone was welcomed and gave self-introductions.

Minutes for the June 14th SSCPP general meeting were approved unanimously by all in attendance.

Home for Little Wanderers Project Adventure Mini Grant Outcomes Report

- Tara and Emily, clinicians at the Home's Southeast Campus, reported on the SSCPP funded grant and shared photos of the kids served using the project adventure materials.
- Serve kids age 7-18 and have both a day and resident program. Kids have significant trauma history. 22 individuals have participated in the program so far.
- Grant paid for training and materials. Have low ropes course at camp.
- Project adventure helps kids with trust, frustration, tolerance, teamwork and communication.

Mike introduced panelists. SSCPP will be focusing more on behavioral health.

<u>Project Outreach</u>: Chief Boteiri provided details on program. More information: https://projectoutreachplymouth.com/

- Includes all of Plymouth County: northern portion coordinated by E. Bridgewater, southern by Plymouth police.
- Partnership to assist with increasing overdoses. BID Plymouth (Sarah Cloud) is a major component of program.
- 12-24 hours after an overdose is a critical time for intervention.
- After an OD, person goes to hospital and, if a follow-up is warranted at home, police visit in plain clothes to offer treatment resources to individuals, family and loved ones. Police do the connecting with the professionals and then step back. Can get most people a bed in about 24 hours.
- Project Outreach has a high success rate. 80-85% of individuals visited go into treatment.

 Program has self-sustained for our 2 years now. Are currently looking for grant funding to help.
- Plymouth's drop-in center is twice a month at New Hope Chapel (2nd and 4th Tuesday). Offer resources at center. E.B. Hope has a drop in center as well.
- Also promoted Smart 911- A person go in and enter information emergency responders should be aware of i.e. child with autism.

- Located in South Shore Community Action Council's building on Obery Street. Opened on July 5th. Bob shared his story- lost his son to addiction.
- Center offers support and peer to peer counseling. Is a 501c3. Only private funded program in state.
- Two main components: intervention/prevention and a resource center.
- Offer programs daily in a comfortable, home-like environment. Want to increase evening and weekend hours.
- Looking to grow and get other funding sources. Saw several hundred people in first month.

SSCPP Announcements:

Changes to SSCPP Grants Process- Will have a major grant tied to behavioral health (mental health and substance abuse) available. Will offer two major grants for this fiscal year for \$25,000 each. RFP to be released by November 1st.
